Combat in the F-4 Phantom II: A Fightergator's Perspective

Please join us for our April 7th NWFMOA meeting. Our speaker is Bob "Kid" Hanrahan, who will speak on flying combat in the F-4 Phantom II all-weather fighter during the Vietnam War. He is a lifetime member of MOAA, MOAA Cape Canaveral, AFA, VFW, and the Vietnam Veterans of America. His volunteer support to MOAACC and AFA has been in the areas of Transition & Career Assistance and Airmen Helping Airmen respectively. Kid and his wife, Linda, moved to the Milton area 15 months ago and he immediately engaged with AFA, PMOAA and The Daedalians.

Kid is a former Air Force Captain, rated Navigator-Bombardier and F-4 Weapon Systems Officer (WSO) who flew Fighter aircraft combat missions in the Southeast Asia. He will cover his training and experiences flying as a back-seater Weapon Systems Officer (WSO), addressing the role of the WSO, the importance of crew coordination, front seater/back seater "seniority" during the tour, Situational Awareness "du jour", the wide variety of mission types, weapons employed, the challenges of weapons effectiveness, the tactics used to compensate for low probability of kill, and "playing it

safe". He will also describe his post-RTU dissimilar air combat maneuvering training at the U.S. Air Force's Fighter Weapons School for Advanced Air Combat Maneuvering (Dog Fighting/dissimilar ACM), a program that made aircrews more prepared for the Air War in Southeast Asia.

Kid achieved over 100 missions during the Southeast Asia conflict in the back seat of the all-weather F-4 Phantom II and he's here to share with us his story, A Fightergator's Perspective, on what it was like to fly combat in the back seat of the F-4 Phantom II.

Thanks to the responses you have already provided to previous requests for input the board has compiled the following list of pros and cons concerning the proposed change:

Pros

Save about \$4,500 per year for publishing & mailing, thus solving current negative cash flow

Saved costs could be used to reduce chapter dues, while charging extra to those individuals wanting paper copies of Defender

Not everyone who gets a paper Defender actually reads it.

No word count limits on articles

No need to columnize articles

No limit on number of pages

Can insert links to related websites

All photos in color

Unlimited ads can be sold

Can standardize fonts and print sizes

Can send digitally to a wide variety of recipients, not just chapter members, at no additional cost

Recipients can download and print Defender or selected articles as they wish

Those not receiving digital Defenders may be "adopted" by someone who does

A special mailing list for printed copies can be created for those unable to receive email copies

Cons

Not everyone gets email, or wants to

Not everyone comes to meetings

Couldn't cash flow problem be handled by a modest dues increase?

What about surviving spouses of deceased members?

How will the saved printing / mailing money be used?

What do most NWFMOA members get for their chapter dues, except for their paper copies of the Defender?

Printed Defenders can be passed around to additional readers

How would eliminating printed Defenders affect our current 5-Star rating from MOAA?

Printed Defenders serve as meeting and dues reminders

Printed Defenders help introduce and publicize guest speakers for upcoming meetings

Printed Defenders include sign-up forms for potential new members

Local Egg Gets Scrambled

Well-known local character Humpty Dumpty was killed in a tragic accident early yesterday morning, when he apparently lost his balance and toppled from the wall of the Kings Castle, where witnesses had seen him sitting only a few moments before.

"He had a great fall," said the Chief of the King's Men as he and all the other King's Men stretched yellow tape around the scene of the accident, and used their swords to scrape up Dumpty's scrambled remains. Although the egg's sudden death has been tentatively classified as an accident, the investigation continues, and officials have neither confirmed nor denied rumors that the Red Queen was seen with Dumpty shortly before the tragedy, carrying a croquet mallet and having a heated discussion with him about omelets.

"I'll really miss him," Alice added. "He was a good egg."

As we celebrate Resurrection Sunday this Easter many wonder what place does this historical event have in our modern age. Some consider worship obsolete and ancient. Others selectively choose what beliefs suit their comfortable lifestyle. A third cluster takes the life, passion, death and ascension of Jesus the Messiah as fact. There are our choices.

One principle every major religion posits is the battle between good and evil, light and dark. This contrast takes place on the world stage, but emanates from within the individual's thoughts and emotions.

Pastoral counselors know this undeniable truth from their daily sessions with individuals wrestling with personal, familial and social conflict.

We who served marched with our light into the darkness. We know good and evil are real, verses those who watch it on the TV or video screens.

Remembering and preparing with fellow commandos for the first time, not knowing if we would survive the hail of bullets and bombs, I clenched several Scriptures that jumped across my mind. Later I reemployed them in our commander's hot wash as he asked for prayer after each mission.

Those silvery words became gold in the heat of war—not hollow chaff recited from a mahogany pulpit surrounded by tiffany stain glass! No, it emanated from the pounding of many hearts looking into the valley of discord.

It seems that every generation hears and responds to the war drums, like those beating in Ukraine. Our hearts are wrenched watching the evening news. We want to do more but what?

An email from the President of the 1800 Ukrainian Evangelical Churches in his country ask us pastors in the West to pray—"It's our weapon against evil and only God can put a stop to the violence and suffering". Prayer builds solidarity with refugees and the defenders.

Scholarship Fund

In the March issue of The Defender I addressed one alternate method to donate to our Scholarship Fund other than writing a check. i.e., an **IRA Charitable Rollover/Qualified Charitable Distribution (QCD)**. This month I am providing some brief info on another donation method that can provide some significant income tax savings to you and/or your estate. This is by leaving a Bequest via listing the charity (e.g., the NWFMOA Scholarship Fund) as an account beneficiary or via your will or trust.

When an IRS code 501c(3) charity is listed as the beneficiary of a taxable account, e.g., a traditional IRA or other taxable retirement account, there is a double income tax savings. Firstly, your heirs or estate do not pay tax on these funds; nor does the receiving charity since they are income tax exempt. This is what deceased Chapter member Lt Col Jim Heavener did in 2016, and what I have done with my taxable IRA accounts (my beneficiaries are all 501c(3) charities). Some of the most common types of bequests include a fixed dollar amount, a specific property, a percentage of the estate, or an individual portion of an estate.

An example of a bequest wording your attorney may find useful: "I give and bequeath _____ (description of property) and/or the sum of \$_____ to NWFMOA Scholarship Fund, Inc., a Florida non-profit charitable organization (FEIN 59-3434498) that is tax exempt under Section 501c(3) of the Internal Revenue Code doing business at 56 11th St., Shalimar, FL 32579. These funds are to be used for the college education of Junior Reserve Officer Training Corps (JROTC) cadets from the high schools supported by the NWFMOA Scholarship Fund, Inc."

Consult an attorney when making or revising a will or trust to ensure compliance with state law and to minimize applicable taxes.

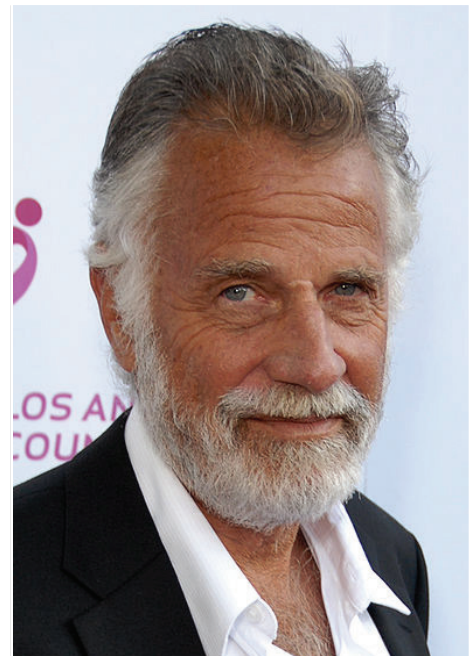
