Our March meeting will feature Mel Ponder, Okaloosa County Commissioner of District 5. He will provide timely updates on matters he and his fellow Commissioners are addressing and answer your questions.

He was the Mayor of Destin from 2014 to 2016, and member of the Florida House of Representatives from 2016 to 2020. During his tenure in the State House of

Representatives, Commissioner Ponder served as the Chair of the Children, Families and Seniors Subcommittee, Vice Chair of the Higher Education Appropriations Subcommittee, and as a Deputy Majority House Whip. He was instrumental in the passage of laws concerning military education and licensure, veterans alternative treatment options, veterans treatment court, VisitFlorida/tourism, child welfare, mental healthcare, and religious freedom. Commissioner Ponder is the owner of *Business Empowered*, a workplace ministry and is Government Affairs Director with the Emerald Coast Association of Realtors. In addition to his political and business work – he is heavily involved in non-profits and outreach to the community. He helped institute the Destin Week of Blessings which is an annual event that unites pastors and churches in the Destin area. Mel is also on the statewide Board for CareerSource Florida, the Florida Association of Counties, and the Florida Faith-Based and Community-Based Advisory Council. Locally he serves on the Transportation Planning Organization, and Ex-Officio Board Member for the Niceville-Valparaiso Chamber of Commerce.

Chuck Merkel served as the evening’s historian and moderator, giving all in attendance a description of the Vietnam War period, the atrocities endured by our POWs, and the courage, sacrifice and tenacity of those being honored. Chaplain Tom Azar gave the invocation. Fred Westfall was in attendance, just as he was 50 years ago on the tarmac of Clark Air Base, Philippines when the POWs made their first stop after leaving Hanoi, Vietnam. Fred was a Captain then, assigned to 13th Air Force. Honorary NWFMOA Member, Jerry Williams, CEO Eglin Federal Credit Union was a sponsor for this historic event. NWFMOA Board Member Bob Allen and Past President Elvira Chiccarelli serve as volunteers at the museum and were there helping. New NWFMOA Member, Col Kim Wintner (Air Force Armament Museum Foundation Treasure) was there, as were many, many other chapter members. It was a great turnout for NWFMOA. And I had the great honor to give welcoming comments while wearing my Vice President of the Air Force Armament Museum Foundation hat.

This month we will continue the **Defender** tradition of welcoming new members and ask them to answer some basic questions to introduce them to our NWFMOA members.



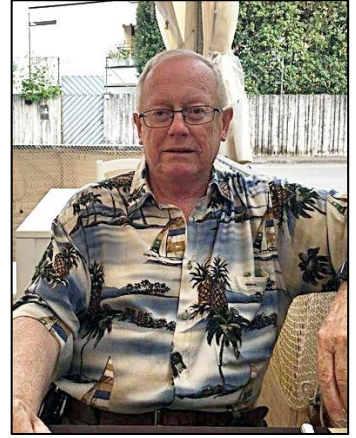
This month we have two new members. First is Colonel Kim Wintner, USAF Retired. It is great to have him as a new member. His responses to our questions are below:

1. What did you do in the Air Force? *Services/MWR career field. Six times a commander at squadron, group and wing levels. Last three assignments: AETC Director of Services/MWR, Randolph AFB, TX; Commander, Mission Support Group, Hurlburt Field, FL; Vice Commander, Air Base Wing, Eglin AFB, FL. Made an Honorary Chief Master Sergeant.*
2. What was your retirement Date? *October 2000.*
3. What was your favorite assignment? *Hurlburt Field. The Special Operations troops were the best. Team oriented.*
4. What funny story would you like to share? *I'm a brand new 2nd Lt at Grand Forks, North Dakota. I get a call at my BOQ from a Lt Col/commander of the Air Defense Command Squadron at 5 am. He tells me to come out to the ADC Alert Facility. We have a dining facility there. Alert dining facilities are the best. Great food and personal attention from the cooks. I jump up, dress, put on parka and gloves, unplug my Pontiac Tempest, start the car, wait 5 minutes for it to warm up and head out. I meet the Lt Col at the door. He was impressive in his orange flight suit. I stepped in and saw my cook behind the serving line, working away. He looked sharp in his starched white blouse with his two stripes, name tag and SAC patch, all in the right places. It's 1970 and the Draft is still on. Young, men join the Air Force to avoid the Army and the war. Some figure out they can shorten their 4-year commitment by "messing up" just enough to be declared 'incompatible,' and get a General Discharge. The Air Force first washed people out of the tougher career fields, assigning them to Supply, Security Police or Services.*

So, I turn to the Lt Col with the "why am I here" look on my young face. He walks me to the end of the serving line. I quickly see that my cook is not wearing any pants. Combat boots, but no pants. He walked to work in his parka without any pants, in 10-degree weather. A month later, he got his General Discharge. Welcome to Services 2nd Lt Wintner.
5. Anything else you would like to share? *still bleed Air Force Blue. I've stayed connected to the local bases through several boards and committees. Currently, I'm Chairman, Destin MAC; Board of Director (BOD), Emerald Coast MAC; Okaloosa County Defense Support Initiatives (DSI) Committee; BOD, Air Force Armament Museum; BOD, Destin Chamber of Commerce; BOD, Mid-Bay Bridge Authority; Honorary Commander, 7th Special Forces Group; Okaloosa County Sheriff's Citizens Advisory Board.*

Formerly: BOD AF Enlisted Village; Chairman, Okaloosa County Economic Development Council; BOD Grace Rides Equestrian Therapy for physically and mentally challenged children and PTSD veterans.

Our second new member is last month's guest speaker, LTC Mel Claxton, US Army Retired. His responses to our questions are below:



1. What did you do in the Army? *Field Artillery Officer, majority of the time but also did Recruiting Duty in Houston Tx for two years, and Pa National Guard, 28 Infantry Division Artillery Advisor for two years.*
2. What was your retirement date? *September 1992.*
3. What was your favorite assignment? *Favorite assignments were my two NATO assignments in Italy, (Verona (NATO Land HQ South) and Vicenza (U.S. Artillery Group Custodial Unit). Also meet and married my wife Annalisa while assigned in Verona, Italy.*
4. What funny story you would like to share. *While with the NATO Command in Verona, I would go out and inspection Italian Alpini Artillery units for their NATO Operational Readiness Test (ORT). During one of those tests, I was walking along the gun line and all of a sudden behind me I heard someone cussing up a storm in a heavy NYC accent. I turned around and only saw Italian soldiers. So I hollered, who had made those remarks. An Italian soldier stepped forward and said he did, in a strong NYC accent. I asked him how he got in the Italian army. Said he immigrated to the States when he was about 5 years old, with his Italian parents and grew up in NYC. After he was 18, he returned to Italy to visit his Italian grandmother and while there was discovered by the local Italian police. He then was drafted into the Italian Army. Seems the Italians do a good job of keeping track of all those born in Italy. Once someone turns 18, they have to (somewhat what we had to do) register for the draft. So when it was discovered he had not done that, he was given a choice, some time in jail or get drafted for one year. He elected for the Army.*

Member Spotlight

LtCol Paul Singleton, USAF (Retired)



Always ready to recruit

Paul Singleton grew up in North Carolina and his dad was the Chief of Police. Paul once got in trouble and his dad put him in jail...he was 7 years old. From that event and the accompanying time in the slammer, he learned a valuable lesson. Always tell the truth.

While in high school Paul worked at the local paper mill. After high school he enrolled at East Carolina University where he met Anne George from Richmond, VA and they were married in 1955. Paul enlisted in the Air Force as an Aviation Cadet during his junior year of college. Days prior to commissioning, each Aviation Cadet had to affirm they were not married. Since Paul was married, he was immediately dismissed from the Aviation Cadet Program.

After his dismissal, Paul returned to East Carolina University and enrolled in their Air Force ROTC program. He graduated from East Carolina in 1958 as a distinguished Military Graduate and was commissioned a Second Lieutenant in the United States Air Force. His career would span 30 years. During his time on active duty, he served on numerous special operations missions as well as a tour in Vietnam and Grenada. His military decorations include: the Distinguished Flying Cross with one Oak Leaf Cluster; Meritorious Service Medal with one Oak Leaf Cluster; and the Air Medal with two Silver and one Oak Leaf Cluster.

Recognizing the importance of a college degree and having personally faced the hurdles of funding such an endeavor, Paul established the Paul Singleton Military Academic Success Fund at East Carolina University which supports not only Veterans, but also Reservists and dependents of Disabled Veterans who do not receive federal funding for textbooks. To date, this is one of the largest gifts to student Veterans at East Carolina University.

Lt Col Paul Singleton, USAF Retired, was inducted into the East Carolina Distinguished Military Service Society on November 18, 2022.

Paul is a long-tenured member of the NWFMOA and has served in numerous Chapter leadership positions to include 1st Vice President twice

CALL TO ACTION

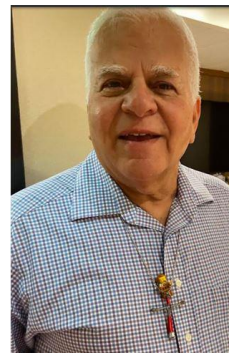
Major Richard Star Act

Your assistance is needed. Last year, the efforts of MOAA and their partners in The Military Coalition came close to having Congress enact the Major Richard Star Act. That legislation is solely focused on supporting 50,000 combat-injured Veterans whose retirement pay is reduced by the amount they receive for disabilities due to combat. This is wrong and needs to be righted. Undeterred and fully committed to seeing the Star Act passed, MOAA and The Military Coalition are again engaging Congress and could use your help. They simply ask each of us to contact our elected officials and state our support. They have made it very easy for us to make that contact. Just use this link provided by MOAA: contacting your senators and representative TODAY. It takes less than 10 minutes to complete, and it will send a letter directly from you to Senator Rubio, Senator Scott, and Representative Gaetz. I have sent my letters of support and respectfully request you do the same. The Major Richard Star Act is a necessary step towards concurrent receipt for all.

What would you rather do than go to a professional football, baseball or golf event? We all enjoy watching with family and friends at home, but nothing replaces sitting and cheering your favorite team right before your eyes.

My family enjoys watching the Olympics. When we go to the Adirondacks, we visit their training center in the mountains. We learned that these men and women, since their youth, made a decision to commit everything to attain their personal and team goals.

Their parents woke them at o-dark 30. They drove all year to a gym or field where they worked out with other young people under the training of a former Olympiad. They were determined and disciplined. They were assisted by a team of coaches, doctors, therapists, dietitians to be the best of the best in their respective field.

There is an excellent parallel between physical and spiritual training. The former sets the paradigm for the latter. We need superior pastors, teachers and elders who can guide the next generation along the way. No one woke up as a “little Christ”. They soon realized that their Heavenly Father had children of faith who were POW's- your patriarch Joseph spent 13 years imprisoned in Egypt, St Paul was incarcerated & beaten for 6 years under Caesar & your son Jesus was humiliated & tortured by Pilate.

Lord in your mercy you added these courageous POWs seated before us as living human testimonies of faith & hope, because their resistance & confidence was in you.

May future generations learn from their physical, moral & spiritual determination to serve DOD and God & may this gathering lead today's youth to raise their hand and take our solemn oath to defend our border & protect the innocent from arrogant dictators around the world.

We ask for continued grace and provision to assist the many disabled and homeless veterans, and to strengthen today's guardians of freedom, projecting justice liberty, and peace around the globe.

Legislative Liaison

“Target on TRICARE For Life”



Mission Advocacy is one of the primary missions of MOAA. If you are receiving MOAA's weekly Newsletters, you are aware that our TRICARE For Life (TFL) health insurance benefit is a target by the Congressional Budget Office (CBO) to cut the federal deficit by either (or both) increasing the TFL Enrollment Fee, or by introducing “TFL Cost-Sharing”. or minimum out-of-pocket costs in TFL, e.g., requiring deductibles and co-payments for medical services.

Currently, our TFL Enrollment Fee is the amount you pay for Medicare Part B insurance. This amount can vary among individuals based on annual gross income. A CBO proposal would require Medicare-eligible beneficiaries (includes a large percentage of our Chapter membership) who choose to enroll in TFL to pay an annual enrollment fee of \$575 for individual coverage or \$1,150 for family coverage.

TFL Cost-Sharing would introduce minimum out-of-pocket requirements in TFL, including an \$850 deductible annually. This means TFL would not cover any of the first \$850 of a beneficiary's Medicare cost-sharing. After this (It gets worse!), TFL would cover only 50% of the next \$7,650 in Medicare cost-sharing. This means TFL beneficiaries could face up to \$4,675 in Medicare cost-sharing a year (This is \$4,675 does not include the \$575 proposed TFL Enrollment Fee above.) This TFL Cost-Sharing proposal by OMB has further implications and costs for those receiving care from a military treatment facility (MTF).

The above information is just a brief description to ‘pique your interest’ and was paraphrased from the March 2023 issue of MOAA’s Military Officer magazine, on pages 10 – 11. **I strongly urge all of you to read this article.** Then contact your Representative and Senators in Congress by sending letters on this topic through the MOAA/Legislative Action Center. Fred Westfall has made it very easy for us to do this by merely going to the nwfmoo.org website and scroll down to the bottom of the home page and click on the flashing “**TAKE ACTION**” button. This will take you to MOAA’s Legislative Action Center, and scroll down to “Tell Congress You Oppose TRICARE for Life Fees”, then click on “WRITE”. While you are there, write to Congress on the many other issues MOAA has there. Very, very simple to do.

I see this OMB proposal as a method to get Medicare-eligible military retirees to forego using our TFL benefits, which we have earned through our military service, and seek other forms of supplemental insurance to Medicare. I suspect that B/Gen George ‘Bud’ Day, USAF, Ret., would be rolling in his grave if he were aware of these proposals!

Annual Scholarship & Awards Luncheon on May 4th; Previous Scholarship Winners to Be Commissioned.

Our monthly luncheon on May 4th will be our Annual Scholarship & Awards event. This year we received ten scholarship applications from JROTC cadets from six local high schools, the most ever. This is the first time we have received more applications than we have available scholarships, which is eight.

Since March 1st, your Scholarship Fund board members have been reviewing, evaluating, and scoring the ten scholarship applications in multiple areas of academic records and test scores, education, honors and awards, community service, work experience, financial need, recommendations by the applicant's JROTC Instructor, and an essay of "Why I should receive this scholarship". This is just Part A of the selection process.

Part B consists of individual interviews with each JROTC cadet applicant by the Scholarship board members. Factors to be scored during the interviews include military bearing & appearance, enthusiasm & attitude, knowledge of current events, and potential for a commission and military leadership. These interviews will take place on March 27th.

After the interviews, each cadet's scores from Part A and Part B will be combined to determine not only which of the eight gets selected for a scholarship, but also, the highest scoring cadet will be awarded the "Lt Col James and Mrs Una Heavener Memorial Scholarship" of \$4,500. The remaining seven scholarships are for \$3,000 each. The scholarships will be presented at our May 4th luncheon, where we will also recognize the 2023 awardees of the MOAA Medal from each of the seven JROTC units we support, and, award certificates of recognition to students from any of the high schools in Okaloosa and Walton counties, plus Navarre High School, who receive an appointment to any of our U.S. military academies.

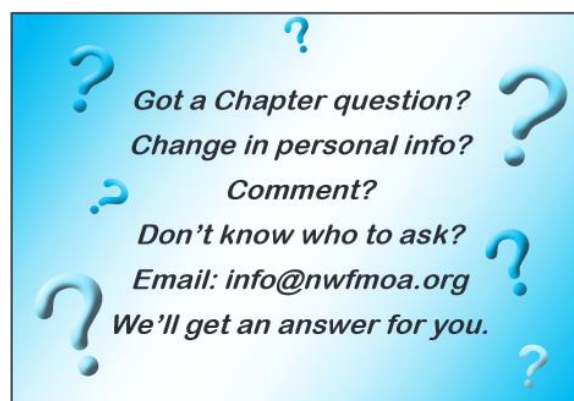
