has been performing on The Defender. The chaplains are (finally) on board! This month we debut the column's new name and banner honoring the Constitutional foundation of Federal chaplaincy. COEXIST is not original or unique. In fact, the graphic is used with permission of its owner, Peacemonger.org, an outreach collaborative dedicated to peace, non-violence, and interfaith cooperation.

The origins of the COEXIST graphic reside with Polish graphic artist Piotr Mlodozeniec. Mlodozeniec created the first coexist design to participate in an art contest hosted by Israel's Museum on the Seam. The contest introduced a traveling exhibition bringing the universal message of diversity and acceptance of the other through art. The exhibition, "Coexistence," has been in 30 different cities around the world "calling for mutual understanding between fellow humans, nations and religions and its opening ceremonies are attended by local leaders of the states it encounters on its global journey" (Museum on the Seam, www.MOTS.org.il).

Like Peacemonger.org, many companies today sell detailed coexist images that use Mlodozeniec's design as the foundation for their religious tolerance products. Most of these promote peace and reconciliation among people of different faiths, belief systems, and world views. The first coexist design focused on harmony between the three great monotheistic faiths – Judaism, Christianity, and Islam.

### Medicare Reimbursement Rates 2012 Update 12

Sen. Rand Paul (R-KY) has introduced legislation eliminating the sustainable growth rate (SGR) governing the reimbursement rate for Medicare physicians, and replace it with a simple,

annual cost-of-living adjustment for these doctors. The Access to Physicians in Medicare Act, S.3337, would end what has become a periodic process in Congress of avoiding scheduled cuts to reimbursements for Medicare physicians. This has required passage of so-called "doc fix" legislation to delay these cuts under the current SGR formula. Instead, it would set up a process under which reimbursement rates could increase slowly each year, capped at 3 percent, based on a cost-of-living increase similar to the one used to calculate increases in Social Security benefits. Paul said this change would remove much of the current uncertainty surrounding the reimbursement rate, which, if cut, could lead to a significant drop in access to medical care. "As an eye surgeon, many of my patients are seniors, and many of those seniors are Medicare recipients," Paul said. "Medicare, in its constant quest to save money, cuts physician reimbursement and in turn puts America's seniors at risk of losing their access to quality healthcare. I know the value of quality care and I want to ensure our nation's seniors continue to get it." Paul said his bill would prevent a cut of about 30 percent to Medicare reimbursements next year, which represents cuts due under the current formula that have been avoided each year. He also said he would pay for this change by repealing expanded healthcare subsidies under the 2010 healthcare law. A related bill, the "Medicare Physician Payment Innovation Act (H.R.5707)" was introduced in the House 9 MAY by Representatives Allyson Schwartz (D-PA) and Joe Heck (R-NV). # Military Voting Rights --How Long Must They Wait

Sixty years ago, June 26, 1952, the Subcommittee on Elections, Committee on House Administration, United States House of Representatives conducted a hearing on absentee voting for military personnel fighting the Korean War. The Honorable C.G. Hall (Secretary of State of Arkansas and President of the National Association of Secretaries of State) testified that most military personnel in Korea and elsewhere would likely be unable to vote in the 1952 presidential election. Because of late primaries, ballot access lawsuits, and other problems, local election officials (LEO) would not have ballots printed and ready to mail until a few days before Election Day, in many cases. There simply would not be enough time for an absentee ballot to go from the LEO to the service member in Korea and back by Election Day.

President Harry S. Truman sent a letter to Congress, on military voting rights on March 28, 1952. In his letter, President Truman called upon the states to fix this problem, and he called upon Congress to enact temporary federal legislation for the 1952 presidential election. He wrote, "Any such legislation by Congress should be temporary, since it should be possible to make all the necessary changes in State laws before the congressional elections of 1954." Well, it didn't work out that way. President Truman left office in January 1953 and the Korean War ground to an inconclusive halt in July 1953.

Finally, in 2009, Congress made the necessary changes. The Military and Overseas Voter Empowerment Act (MOVE Act) amended the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). As amended, UOCAVA now explicitly requires every state to mail out absentee ballots to military and overseas voters by the 45th day preceding any primary or election for federal office. See 42 U.S.C. 1973ff-1(a)(8)(A). This is section 1973ff-1(a)(8)(a) of title 42 of the United States Code. Your LEO must have absentee ballots printed and ready to mail by Saturday, September 22, so military personnel from your community will be able to vote in the November 6 general election, no matter where the service of our country has taken them. But the fact this is required by federal law does not necessarily mean it is going to happen. There are more than 7,500 LEOs administering absentee voting for federal elections, and many of them are ignorant of their obligations under federal law.

Mlodozeniec's basic design is uncomplicated and easy to understand. The design uses three symbols that stand for Islam, Judaism, and Christianity. Mlodozeniec modified the word "coexist" in the following ways:

- for the letter "c," a crescent moon representing Islam is substituted
- for the letter "x," the Star of David representing Judaism is substituted
- for the letter "t," a cross representing Christianity is substituted

Newer designs add additional symbols:

- for the letter "o," the peace symbol or pagan/Wiccan pentacle is substituted
- for the letter "e," a male/female symbol or a scientific equation is substituted
- for the letter "i," a pagan/Wiccan symbol is substituted
- for the letter "s," a Chinese yin-yang symbol is substituted

As the military's Chaplain Corps expands to include faith traditions beyond the big three of Christianity, Islam, and Judaism, harmonious and cooperative coexistence remains essential. We hope the new name and banner of this column will celebrate and honor one of the foundational missions of the military chaplain: to protect the service member's constitutional right to the free exercise of religion.

# Auxiliary Advocate

MOAA has many publications to guide you as you put your affairs in order. Of special interest to military survivors are the Personal Affairs Action Guide, Turning the Corner, the Survivor's Checklist, and the Auxiliary Checklist. As auxiliary members, we already have gone through much of this process when our spouses died. Now we have to arrange our own affairs to help our families when our time comes. To download these publications, visit www.moaa.org/infoexchange. To purchase a hard copy version of these publications, call MOAA's Member Service Center at (800) 234-MOAA (6622).

As the years go by, we tend to postpone actions along this line, figuring we have plenty of time. I've talked to many friends in their 70s and 80s regarding their degree of preparedness and have received varied comments. Some say that will be their children's problem (hopefully their spouses didn't feel that way and leave them without the necessary information). Others don't want to think about it, because it seems like an insurmountable task. Some have started a system of putting labels on items selected to leave to various recipients. Older folks downsize and try to get their children to take favorite items prior to breaking up the household, but many are finding their cherished items are not wanted by modern families. Others feel moving is too much work and then resent their children when they have to move and potentially give away their possessions. If you eventually have to move to be near family, make the transition while you still can make your own decisions and arrangements.

Make sure you have a will, and try to anticipate probate by adding an executor to your financial accounts in advance. Double check your accounts to ensure you have the correct form of ownership/survivorship and beneficiaries established. Everyone should have a medical power of attorney given to a relative, or a responsible party, to cover legalities of medical care. Your nearest military legal office usually provides dependents with help in setting up a will and powers of attorney as needed, so check for walk-in dates and times. To find out more information about estate planning, including tips on establishing a will, a living will, and a power of attorney, visit www.moaa.org/estate. With age comes a greater risk of diminished mental capacity, so it's important for families to step in and manage the care for aging parents. We understand this is an unpleasant subject to consider. However, a little preparation in advance will smooth the way families react and handle the stress, and we will know we have done what we could to leave a good memory. (Source: MOAA *The Affiliate*)

It is not our job to protect the people from the consequences of their political choices." Quoting from Marbury v. Madison using Chief Justice Marshall's words, the Court went on to say: "The peculiar circumstances of the moment may render a measure more or less wise, but cannot render it more or less constitutional." It will be interesting to see where this leads. Of course, you, as informed citizens have the right to vote, if you choose, and the next few months into November will be important in that regard. # How "Green" is Your Garbage?

Last month I managed to fill a 20 lbs article about recycling fluorescent bulbs with only 2 lbs of information. Although this month's tip is equally important, I won't overtax your curiosity before I get to the bottom line.

Lithium batteries are now very popular in portable electronics devices such as cameras, watches, cordless phones, and cordless alarm systems where long life is very important.

When discarded inappropriately, they do bad things for the environment and even nastier things when exposed to high heat. They were cited as the cause of a fatal UPS jumbo jet crash in late 2010, so toting a suitcase of these batteries onto an airplane will probably draw serious criticism from the TLA. Get the picture?

Next time you're en route to Home Depot to discard you fluorescent bulbs, take your old lithium batteries with you. You can find a recycle facility by going to http://www. call2recycle.org and entering your zip code. I found three locations in Niceville: Radio Shack, Sears, and Ace Hardware. No charge for disposal. Radio Shack personnel were very appreciative I was recycling the batteries and praised my "greenness."



Please contact your LEO and remind him/her of the requirement to mail ballots by September 22, and tell the LEO you will be back on Monday, September 24, to determine if the ballots have been mailed. If you find your LEO expects to miss or has missed the 45-day deadline, please contact CAPT Samuel F. Wright, JAGC, USN (Ret.), Director, Service Members Law Center, Reserve Officers Association 800-809-9448, ext. 730, Email: SWright@roa.org .
