## Some SOF Secrets You Didn't Know

I'm very aware that a large part of our membership has some Special Ops experience in one way or another. And I'm sure that some of you have flown SOF aircraft. But I'm also fairly sure you'd be interested in hearing some SOF insights that you hadn't heard before. One very qualified person to do that is our August speaker, Ken Leone. He's worked C-130 issues from many different angles as a flyer and staff officer on some "unique" projects.

Ken entered the Air Force in 1967 at the height of the Vietnam War. He has Bachelor's and Master's degrees in aeronautical engineering and to round things out, a Master's degree in Software Engineering. He was an instructor pilot/ OIC of the flight simulator for C-130 tactical airlift at Langley AFB, VA. He also served a combat tour in the AC-130A gunship in Thailand in 1971 and a short tour in the airfield survey office in Vietnam in 1971. He returned for another short tour in tactical airlift to Vietnam in 1973. He then worked in AF Systems Command on the modification of special ops aircraft and integrating cruise missiles into various aircraft. He completed his Air Force career in the Weapons and Tactics office at Hurlburt and in munitions development/conventional cruise missiles at Eglin AFB. Ken retired as a Major in

1988. He then worked as an independent software consultant, university instructor, and IT consultant for 20 years. Ken has worked on several veterans celebrations at the Eglin Armament Museum and has served as a special master to the court on lawsuits involving software issues. 

- If you have grandchildren who have school programs or sporting events, you can attend and be there for them. Perhaps, their school needs volunteers or mentors.
- Maybe your church sponsors a grief support group. Listening to speakers and sharing with others might help you process your loss.
- Calling another widow or widower and inviting them to a MOAA meeting will help both of you keep that connection to military life. Offer to help. You could represent surviving spouses if that position is not filled.
- Volunteering to help at your church or for a community function will bring you as much reward as you will give to others. Every group needs new faces and willing hands.
- Try something you haven't done before. I became a docent at our Fine Arts Center. I loved touring visitors of all ages. For many children, this was their only exposure to art. Also, other docents became my new friends.
- Use your work-related skills. I volunteered to teach a life story writing class at the nonprofit in my community. That brought a group of strangers together who became new friends as they shared their amazing life stories.
- Discover a new talent. I moved this summer and joined the drama club at the senior center. I hoped to find people who wanted to attend plays.

# Legislative Issues By Dave Parisot

**COLA for 2018 Pay Adjustments**: The Consumer Piece Index (CPI) for 2018, upon which the Cost of Living Adjustment (COLA) is based, is scheduled to be released on August 14th. This COLA will determine the amount of any increase to military retirement pay and to social security payments for 2019. At the end of June 2018 the CPI was 2.7 percent above the FY 2018 COLA baseline (per the MOAA website). Unless there are drastic economic changes by the end of July, it appears military retirees and recipients of social security payments should get a small increase in our monthly payments for 2019.

**MOAA Advocates for All the Troops**: In the July 2018 issue of The Military Officer, MOAA President Lt. Gen. Dana Atkins commented "Sometimes I hear, 'MOAA only cares about officers—why aren't you interested in the issues facing enlisted servicemembers and veterans?' Perhaps you have heard this as well. But it is easily countered with a look at what we do. MOAA is an officer-based organization, but we advocate on behalf of all uniformed servicemembers and their families. I often say our advocacy is 'agnostic'. The majority of the work we do benefits enlisted personnel as well as commissioned officers. While they do not qualify for membership, we have their backs with our strong focus on military pay and benefits"

General Atkins' article continues by giving several examples of MOAA advocacy which impact across ranks, e.g., a 2.4 percent pay raise for all uniformed personnel; getting fair compensation for those who had to medically retire before completing 20 years of service (90% of whom are enlisted); and, working VA and health care issues with Congress, the White House, and other veterans service organizations. General Atkins credits much of the success of MOAA to those in the MOAA chapters who contact their Congressional representatives and senators on MOAA agenda items. MOAA's most recent 'call for action' is to defeat the increases in Tricare rates in the Senate version of the FY2019 Defense Bill (which Scott Berry addressed at our July luncheon).

General Atkins concluded his article with: "We can all look at the work we do with great pride, knowing MOAA is making a difference for all servicemembers and veterans and their families who have sacrificed for our

country. At MOAA, we never stop serving for the good of everyone in the military community."

As members of MOAA, we each must do our part in advocating to our Congressional members on issues MOAA has identified as priority matters for the good of all our uniformed servicemembers.

In the North Country of upstate New York, a few miles from the Canadian border rests the small dwindling town of Dannamora. The only remaining employer is the state maximum security prison nicknamed "Little Siberia" for its' remoteness and harsh frigid winters. At the end of the complex is a cut off to a small farming area, replete with horse farms and rolling hills.

While stationed at Plattsburgh AFB I would drive on the road named "Gen. LeRoy Manor." Coincidently, at one of MOAA's installation of officer's meeting our president Scott introduced me to a fellow New Yorker. He shared his early history — where he was born, schooled, married and worshipped. It took me a few minutes to realize that here is the man behind the named street.

Last week at a Dannamora town meeting I mentioned that General Manor often returns in the summer to the house where he grew up. Many of the council members and attendees had no idea the street they daily drive on was named after a national war hero. I highlighted his involvement in WW2 and Vietnam and that he was a highly decorated pilot and commander, and that France awarded him the medal of Knight of the Foreign Legion. General Manor was also president of the largest military officers association and attended Bob Hope chapel, and last year the Destin Florida airport was renamed in honor of him. I encouraged them to have a meet, greet and recognition event this summer when he returns.

Often we meet individuals at meetings, social events or places of worship who surprise us. As conversations grow we discover how an ordinary human being rose from humble beginnings and was involved in a critical events that contributed to the betterment of society. Like many Americans my family is drawn to national monuments, libraries and parks with a rich history.

True servants rarely advertise their courageous deeds; it only takes time to be 'other-centered' and ask the Continued on page 7
