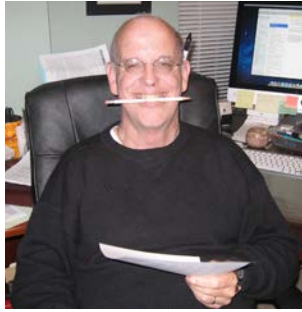

## Auxiliary Corner: What Does It Mean to Be Gold?

My son, 24-year-old Sgt. James Casey Joyce, an Army Ranger, was killed in action in Somalia Oct. 3, 1993, in the Battle of Mogadishu, better known as Blackhawk Down. Sometime after his death, I received — from whom, I can't remember — a pretty gold pin with a purple background and a gold star in the middle. I came to learn the pin was given to me to wear as a symbol of my son's service and sacrifice.

Fast-forward to when I wore my Gold Star pin to a conference. Most of the people there knew about my loss. As I was talking with a group, an acquaintance walked up, pointed to my pin, and said, "What a pretty pin!" "Thank you," I replied. "This is my Gold Star pin. I am a Gold Star mom." Then she said, "Oh, how wonderful! What in the world did you do to earn that?"


What do you say in this situation? What do you do? I quickly figured out she did not know anything about the Gold Star and what it signified. So I explained about the Gold Star pin and what I did to earn it.

There are many stories like mine. But even some people in the military are unaware of the Gold Star and its significance. Imagine having to explain repeatedly what the Gold Star represents — the death of your child or spouse who fought and died for our country — on a service flag, a sticker in a car window, a license plate, or a pin on your lapel.

## Legislative Leanings... by Bill Van Hoesen



**Bill Van Hoesen** (R-Wisc.) – mitigated sequestration's cuts to defense programs in FY 2014 and 2015 by \$31.5 billion. The full cuts return in FY 2016 unless Congress acts. The president indicated his FY 2016 budget submission will include an extension of sequestration relief.

In earlier remarks Army Chief of Staff Gen. Ray Odierno painted a grim picture for the services if sequestration resumes. "This is a lousy way to do business," he said and described FY 2016 as a "breaking point." If the cuts return it would seriously degrade the Army's capability to execute its mission requirements.

A growing consensus in Washington to de-trigger sequestration is an encouraging sign, but many obstacles remain. The last major deal to ease the effects of sequestration was done on the backs of military retirees. A future fix must carefully balance budget and defense concerns without singling out the one percent of Americans who serve in uniform with a disproportionate share of the burden. Reach out to your

legislators, Sen. Rubio, Sen. Nelson and Rep. Miller and ask them to end sequestration.

The Budget Control Act of 2011 chained a ticking time bomb to America's national defense capabilities and the devastating cuts from sequestration resulted in furloughs, force cuts, and reduced training hours.

Unless Congress acts to repeal sequestration and replace it with an alternative debt reduction deal, another even more devastating round of defense cuts will be required beginning in FY 2016.

Please put partisan politics aside and develop an alternative debt reduction package that fairly balances required sacrifices and avoids disproportional penalties for service members, retirees, and their families.

# Treasurer's Update

I hope everyone is enjoying the beautiful fall weather. I sure am. I just wish we could get one more month of this and perhaps trade in the heat and humidity of August in return. It was sure cold yesterday morning during my son's soccer game though. The temperature was in the low 40s, and I made the mistake of showing up to coach the game in my athletic shorts. I am used to running in shorts and a T-shirt with temperatures in the 40s, and I did plenty of running during the game. The wind is what got me though! I usually wind up tying shoelaces for 2 or 3 kids in the middle of each game, and I had a pretty difficult time getting that done with my extremely numb fingers.

As the holidays approach, I want to remind those of you who renew your membership annually that your 2015 membership fee is due and payable on or before 31 December. Thank you to those of you who have already completed the task. You may have received a reminder email from me asking you to renew your membership in the near future. I don't mean to be pesky, but I know how busy things get as the holidays approach. Better to get it done now so you can forget about it for another year.

Paying your dues is easy. Simply go to the last page of the Defender and fill out the Membership Application/Renewal on the bottom of the page. Make out a check to NWFMOA for the correct amount and mail the form and your check to the address listed on the form. If you are an Auxiliary Member, you pay only one half of the listed rates for Regular Membership.

If you are not a Life Member, but you don't know when your membership expires, check the mailing label on your hardcopy of the Defender. There should be a year listed on the mailing label. For example, mine says 2015. That means my membership is paid up through calendar year 2015. If yours

says 2014, your membership expires at the end of this year and it is time for you to renew. If you opted out of receiving the Defender in the mail and you download it from the NWFMOA website instead, you will not have the mailing label to reference for your membership expiration date. In that case, just email or call Scott Berry and he will have the information for you.

On the business front, the Chapter is financially solvent. Technically, we were in the black for October, but that is only due to Military Ball RSVP payments that will flow out of our account again when it is time to pay the final bills for the Military Ball. The overall effect is that we are still operating in the RED by several hundred dollars every month.

Speaking of income, now is a great time to start thinking about your income tax return for 2014. Income tax identity theft is on the rise, and there are a few steps (but not many) you can take to protect yourself. In cases of income tax identity theft, a person files an income tax return as if they are you using your social security number (SSN) and other personally identifiable information. Usually, this happens early in the new year. Victims are often unaware of what has happened until they go to file their income tax return with the IRS. The IRS informs the victim they cannot file because someone has already filed using the victim's SSN. This is where things get very painful, especially if you are expecting a big refund. The IRS first requires you to prove you are you by providing myriad documents of different sorts. Once you've accomplished this monumental feat, the IRS will issue you a unique personal identification number (PIN) only to be used for filing your income tax returns in the future. If the IRS owes you a refund on your tax return, expect to wait many months, and in some cases longer than a year to receive your refund.

So, what can you do to protect yourself? The IRS doesn't really have a good answer to this problem yet. I have not personally experienced income tax identity theft, but I have family members who have. My advice is based on their experiences along with recommendations from published financial experts. First, file your income tax return as soon as you have all of the required documents. For most of us, those documents tend to be available by the end of January or early February. As soon as the holidays are over, start gathering up your documents and be ready to file as early as possible.

Next, plan to e-file if at all possible. In today's world of rampant identity theft, do you really want all of your critical personal information moving through the US Postal system? The crooks looking to steal your identity know very well that any mail going to or from the IRS is likely to have a nice stack of paperwork inside complete with someone's sensitive personal information. You can e-file conveniently from home using any number of reputable tax preparation service websites. You can also e-file on the IRS website at IRS.gov. If you are not so computer savvy, splurge a little and have a

## Required Documents At Time Of Death

**DEATH CERTIFICATE** with cause of death (long version if a Florida certificate)

**MARRIAGE CERTIFICATE**

**BIRTH CERTIFICATE** (for deceased member and spouse)

**DIVORCE DECREES or DEATH CERTIFICATES**

(from previous marriages for both the member and spouse DD214 (it will show DD214 on the bottom left of the military form))

**RETIREMENT ORDER** (not the same as the DD214, it is a Special Order)

**GOVERNMENT LIFE INSURANCE POLICY** (either Veterans Group Life Insurance (VGLI), or National Serviceman’s (NSLI)

**BANK ACCOUNT/ROUTING NUMBERS, ADDRESS & PHONE NUMBER** (this is for Direct Deposit form we will do for any annuity, if applicable, to be direct deposited)

**Note:** (if it is a joint account you must notify you bank prior to your appointment with the Casualty Assistance Office.)

**FUNERAL SERVICE ITEMIZED BILL-STAMPED PAID IN FULL**-if you are awaiting the insurance company to pay the funeral off, or the funeral cannot be paid in full by the time of your appointment; we will request a copy from the funeral home once it is paid. You do not have to bring it if it is not paid in full.

**PROOF OF ANY VIETNAM TOURS/ASSIGNMENTS** (if your spouse was ever in Vietnam from 1961-1971,

please look for a members personnel records and performance report, decoration citation, or an order, or something stamped from RVN, Republic of Vietnam.

This is required for any Agent Orange claims. Veterans did not have to be approved for Agent Orange by the VA before death. It can still be approved for the widow, if the VA is satisfied with the documentations provided  
**NOTE:** If you are unable to find any of the above documents, we can still process paperwork for your benefits. We do need to have the death certificate with the cause of death in order to file the claims.

CPA complete your tax return and e-file for you. After years of doing my own income taxes, I finally went to a CPA to file my 2013 return, and was very pleased to see her accomplish in 30 minutes what had become a full weekend chore for me. It was quite a relief.

Finally, if you are one of those people who tends to receive a large income tax refund every year, seriously consider reducing your monthly income tax withholding so that you owe just a little bit of money to the IRS instead of the IRS owing you thousands of dollars. That way, if you do become a victim of income tax identity theft, you won't be waiting an eternity to receive a refund. Instead, the IRS will be much more interested in resolving your situation quickly so that the IRS gets paid sooner rather than later.

If you read the Treasurer's Update in last month's issue of the Defender, you may recall my discussion of freezing your credit, also known as placing a "security freeze" on your credit file. Freezing your credit unfortunately does not prevent income tax identity theft. And as I mentioned earlier, the IRS still does not have a good answer to this growing problem. However, following the steps I've laid out will give you some measure of protection and help you minimize the damage in the event you become a victim.
