Legislative Musings...by Bill Van Hoesen

I received the below midmonth so it may be OBE. If so, it will be interesting to compare what Congress said it was going to with what it actually did. If they haven't taken action by the time you receive this, it just means what else is new.

"Congress took a small step this week towards repealing recently passed COLA cuts for military retirees. Both the House and Senate

passed the Consolidated Appropriations Act (H. R. 3547) – an omnibus package to fund the federal government for the remainder of the fiscal year – exempts medical (Chapter 61) retirees and survivors from the COLA cuts. A comprehensive fix could be on the way.

Sen. Bernie Sanders (I-Vt.) is planning to combine the Senate omnibus veterans' benefits bill with a full repeal of the COLA cuts. The new bill (S. 1950) has the support of Senate Majority Leader Harry Reid (D-Nev.) and could be fast-tracked to the Senate floor for a vote soon. The original veterans' legislation (S. 944) enjoyed bipartisan support when it cleared the Senate Veterans Affairs Committee last fall. The new bill incorporates repeal of the unfair 1 percentage point COLA reduction for working age military retirees and currently serving members established in the Balanced Budget Act. It also addresses a number of major MOAA priorities for veterans including:

1) Extension of advance appropriations for all Dept. of Veterans Affairs accounts

2) Authorization for in-state tuition rates at public colleges for all student veterans using the new GI Bill
3) Honoring as veterans certain career Reserve members eligible for reserve retired pay
4) Authorization for Iraq and Afghanistan surviving spouses to the Post-9/11 GI Bill via the Gunnery Sgt. John D. Fry Scholarship Program
5) Patention of DIC by aligible widows who remarry

5) Retention of DIC by eligible widows who remarry at age 55

6) Improved care and services for veterans who were sexually assaulted in military service

7) Extension of VA health care enrollment opportunity for OIF-OEF veterans from 5 to 10 years

8) Renewal of the VOW to Hire Heroes Act veterans retraining assistance program

MOAA believes Congress must reach a bipartisan solution to fully and immediately repeal COLA-cutting provision, and address critical veterans' needs." (MOAA Legislative Update, 17 Jan 14)

What a busy year 2013 has been for the Auxiliary Member Advisory Committee (AMAC)! We welcomed two new members to the committee in April: Sharon DeVaney, Pikes Peak (Colo.) Chapter, and Gray Warmunde, Calusa (Fla.) Chapter. While we reluctantly accepted Warmunde's resignation due to personal obligations over the summer, we appreciate her contributions to the AMAC.

In April 2013, the AMAC participated in the national Storming the Hill event, which focused on TRICARE increases, military pay raises, concurrent receipt of military retired pay and VA disability, and the Survivor Benefit Plan/Dependency and Indemnity Compensation (SBP/DIC) offset.

The AMAC focused on educating members of the 113th Congress on the impact of the SBP/DIC offset. With the help of auxiliary liaisons; MOAA President Vice Adm. Norbert R. Ryan Jr., USN (Ret); organizations in The Military Coalition; and an SBP/DIC offset Facebook page, we gathered more than 100 surviving spouses from 20 states to come to Washington, D.C., to lobby on this issue. These individuals represented Gold Star Wives, the Society of Military Widows, and other military organizations, as well as family and friends.

On July 17, the AMAC successfully led its first Hillstorming event focused only on the SBP/DIC offset. We began the day with a breakfast with congressional legislative assistants and military legislative assistants. Sen. Joe Wilson (S.C.) and Ryan spoke about the injustice of the offset. Two surviving spouses, Traci Voelke and Suzanne Gerstner, delivered personal, compelling testimonials on the offset's impact on their families.

Following breakfast, 38 teams stormed the House, while four teams, including Ryan and MOAA's Government Relations Director Col. Mike Hayden, USAF (Ret), tackled the Senate to gain cosponsors and support for H.R. 32 and S. 734 — bills that would repeal the SBP/ DIC offset. Teams left the Vow of Honor brochure, an SBP/DIC fact sheet, and a page of five surviving spouse testimonials in each office.

When the "stormers" returned home, AMAC members encouraged them to visit local congressional offices, send emails and letters, and make phone calls to garner support for H.R. 32 and S. 734. Currently, H.R. 32 has 186 cosponsors, and S. 734 has 31 cosponsors. 2013 Auxiliary Liaison of the Year Ginny Canady, from the Riverside March Field (Calif.) Chapter, with Edie Rieken, the 2012 recipient from the Portland (Ore.) Chapter, were recognized at MOAA's 2013 annual meeting in Colorado Springs, Colo. Rieken had to cancel her trip to the 2012 annual meeting because of the effects of Superstorm Sandy.

The committee unanimously decided to maintain the current chair, Patricia Bergquist, and vice chair, Kathy Prout, through 2014.
