Volunteered for Vietnam. Served consecutive tours (1.5 years). Commanded a Troop operating M113 Armored Personnel Carriers. Mission was to clear the road for daily resupply. On average, the enemy would ambush us once a week. Awarded: Silver Star; 2 Bronze Stars (one with V device), Purple Heart.

FBI

Served 27 years. Career highlights include being the Supervisor of the Violent Crime Squad, (20 men), in Atlanta, GA for 10 years. In that position, was instrumental in ending the Atlanta FBI Office hostage situation and the Atlanta Prison riots.

MOAA Special: TRICARE For Life Benefit Targeted by Congressional Budget Office Report

A biennial report from the Congressional Budget Office (CBO) takes aim at TRICARE For Life (TFL), offering two proposals among its options to cut the deficit that would significantly increase costs for seniors using the TFL benefit.

Both TFL options would reduce the federal government's mandatory spending via unacceptable plans to shift health care costs from DoD to uniformed services retirees. Similar concepts have been presented in past CBO reports, which are issued every two years to provide information to lawmakers confronting budgetary challenges.

While these are not legislative proposals, MOAA believes we must address them as serious threats given recent cuts to the TRICARE pharmacy program and the series of TRICARE fee increases associated with military health system reforms.

My wife and I recently celebrated our wedding anniversary on a cruise to the Southern Caribbean. Before departing, I contacted the cruise ship headquarters in Miami and offered to officiate the Sunday worship services. They agreed and provided a meeting room and advertised on the ship. Many of those who attended came to the Sunday worship service.

Soon thereafter, the activities director Kevin hosted an open meeting for all veterans. The first meeting about 15 attended, and the second and third about 20 and 25 respectfully.

Kevin mentioned a possible meal on the last sea day.

He was military child, and asked for some ideas for a Veterans Day celebration. We continued our brainstorming, and confirmed the final night, 8 pm in the main dining room. Spouses and friends were invited. Seating for 45 was set up along the wall of the dining room.

When Kevin arrived at 8, the restaurant was packed full. The waiters hurried taking orders for appetizers, soup, and entrée. We asked them to please wait ten minutes before serving the food on the table.

Kevin and I stood in the aisle and opened our faded flag. Everyone automatically stood up. "Veterans present arms." Spouses placed their hand across their chest. Everyone in the restaurant upon hearing "I pledge allegiance to the flag..." paused, looked over and put their forks and knives down. Waiters moved backwards. The Maitre de stopped seating guests. Silence surrounded the standing seniors. "One nation under God..."

"Order arms" and I offered my prayer. Then Kevin started his solo "Oh say can you see ..." We joined in "By the dawn's early light..." Then, to everyone's amazement, the entire restaurant rose from their crowded tables and exclaimed in one mighty chorus, "What so proudly we hail..." with their hands across their chest. Tears flowed. Hands trembled. We were carried back in time and up to a higher place.

"For the land of the free, and the home of the brave." Men and women solemnly lowered their hands, pausing to dry their faces. Spouses saw their younger man. Then before we could sit down, fellow guests in the dining room came over and hugged us. They thanked us, "Oh my gosh that was beautiful...I couldn't believe my eyes... I really needed to hear that...thank you for your service." They were Americans, Canadians, Germans, and Asians. The waiters later told us they grew up near Subic Bay and Clark AFB.

As we ate our meals, many thought up to that point that the highlight of the cruise was a certain excursion, the excellent food and service, the musical artists who performed in the atrium or even the evening shows presented by comedians, magicians, singers and dancers.

But that all changed; there was a deep internal gratitude for what our nation has given us. Yes, this is Valentines month, but the love for our nation is something we can all share, any time and any place. Our memory was our mission; our dignity is in our defense; faith in our freedom; unselfishness in our standard, and holiness in our American heritage!

We may have different denominations, nationalities, religious beliefs, political leanings or economic backgrounds, but the pledge of allegiance and national anthem are our creeds that unite us.

It brought me back to my grammar school where every morning a sole student walked up to the flagpole and began, “I pledge allegiance...”

Those early student pledges revealed themselves to be rich with meaning, conviction and history. Many vets finally felt appreciated after their dismal welcome after the Vietnam War. I felt so proud of those men and women who stood up and thanked us for the sacrifices we made.

We are part of a larger family that coalesced and stayed alive. There is a strong undercurrent that runs across every town in America. Don’t wait for Veteran’s or Memorial Day or a funeral. This spontaneous service touched the hearts of onlookers and shook the oath-filled hearts and minds of every veteran, spouse and child who ordered arms and sang, “At the twilight’s last gleaming...”

“How Many Veterans Are in the 118th Congress?” By: Brenden McMahon DECEMBER 20, 2022
(Note: The following article is copied from the on-line MOAA Newsletter dated December 22, 2022.)

More veterans will hold seats in the 118th Congress than in the previous session, reversing a long term decline in prior-service representation. Of the 535 congressional seats in the new Congress, 97 of them will be filled by veterans – 80 in the House and 17 in the Senate. That’s up from 92 in the 117th Congress. Seven of those veterans are women – the most in congressional history, per a Military Times report.

Here’s a breakdown of those veterans:

Branch of Service:

- J Army/Army Reserve/Army National Guard: 43 lawmakers (36 in the House, 7 in the Senate)
- J Navy/Navy Reserve: 27 lawmakers (22 House, five Senate)
- J Air Force/Air Force Reserve/Air Force National Guard: 15 lawmakers (13 House, 2 Senate)
- J Marine Corps/Marine Corps Reserve: 15 lawmakers (11 House, 4 Senate) Note: These figures count some members twice – Sen. Todd Young (R-Ind.) served in the Navy and Marine Corps, Rep. Brian Babin (R-Texas) served in the Army and Air Force, and Rep. Rich McCormick (R-Ga.) served in the Navy and Marine Corps.

Party Affiliation: Of the 80 veterans in the House, 62 are Republicans and 18 are Democrats. Of the 17 veterans in the Senate, 10 are Republicans and seven are Democrats.

Age Range: 3 of the veteran lawmakers are in their 80s, 14 in their 70s, 19 in their 60s, 31 in their 50s, 21 in their 40s, and 9 in their 30s.

Gender: All but seven of the 97 veteran lawmakers are men.

Critical Role of Veterans in Congress: The unique challenges faced by servicemembers, and their families, makes them critical on Capitol Hill. Junior (and even some senior) elected officials without military experience rely on veteran lawmakers to educate them on how DoD and the VA operate. Veteran lawmakers tend to be the fiercest advocates for the uniformed services and veteran communities in Congress, and as the federal legislature becomes more heterogeneous, their role in the legislative process will become even more critical. Fewer veteran lawmakers means elected officials will have less firsthand experience with currently serving and veteran issues. That could lead to a lack of prioritization for defense- and veteran-related legislation, making it harder to pass the National Defense Authorization Act (NDAA) and defense and veteran appropriations on time.

Role of MOAA and Its 350,000+ Members: Servicemembers, veterans, their families, caregivers, and survivors need to be their own advocates now more than ever, especially with the number of veterans in each new Congress remaining lower than previous decades. MOAA and other military and veteran service organizations also will play an even more pivotal role as they advocate to protect service-earned pay and benefits.

How can you make your voice heard? MOAA offers a diverse set of resources for our constituents to contact their elected officials. These include:

-) **MOAA's Legislative Action Center.** Here you can write and call your lawmakers using MOAA's pre-written campaigns on key issues impacting the uniformed service and veteran communities.
-) **MOAA Councils and Chapters.** Hundreds of MOAA affiliates across the nation offer a new way to engage with your community. You can also meet, collaborate, and socialize with fellow servicemembers.
-) **Online and Printed Publications.** MOAA's email newsletter and magazine are two key ways members can stay up to date on the association's legislative advocacy.

MOAA looks forward to engaging with both veteran and non-veteran lawmakers in the 118th Congress and will strive to build bipartisan, bicameral partnerships as we pursue our legislative advocacy goals in the new Congress."

Although this email was addressed to me, it is the combined efforts of our Chapter officers and members and other community donors who deserve the accolades of this email. The real benefactors of our 2022 Community Outreach Project are the 255 junior enlisted families who received the commissary gift cards in November.

Our Chapter will again submit a request for a MOAA Foundation Community Outreach grant for 2023 later this month to continue our program to assist junior enlisted families at our local bases. This will be the sixth consecutive year our Chapter has participated in the MOAA Foundation's Community Outreach program.

2023 Wreaths Across America (WAA): The date for this year's laying of holiday wreaths on the graves of Veterans is Saturday, December 16th. For 2022, the Chapter collected and donated \$300 to purchase 20 wreaths "In Memory of Deceased NWFMOA Members and Spouses". For 2023, we are taking advantage of WAA's 'early purchase' program whereby we can purchase two wreaths for the price of one. At the Chapter's Board of Directors meeting on January 4th, the Board allocated \$495 to purchase wreaths for 2023. At regular costs, this amount will purchase 33 wreaths; but, with the 2-for-1 special, it will provide 66 wreaths to be placed on Veterans graves at our local Beal Cemetery. There are approximately 1,800 Veterans' graves at the Beal Cemetery. Last year's project provided a total of 1,200 wreaths, so we were about 600 wreaths short. Hopefully, our increased purchase will help bring our local community closer to achieving the goal of having a wreath for each Veteran.

As in 2022, our purchase of wreaths for 2023 "In Memory of Deceased NWFMOA Members and Spouses" is being coordinated through the Choctawhatchee Basin Chapter of the Daughters of the American Revolution, thereby helping this local non-profit increase their purchase of sponsored wreaths.

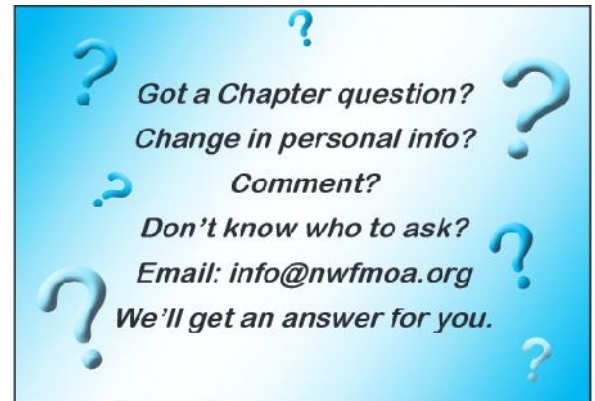
