DEFENDER EDITOR Fred Westfall: <u>defender@nwfmoa.org</u> I thought I would give a brief recap of some happenings this past month. First, Fred Westfall and I attended the **Florida Council of Chapters** (FCoC) Convention in St Augustine, FL. While there we engaged with MOAA National staff members, to include Gen Kelly, the MOAA President, the senior leadership of FCoC, and Chapter leaders from across the state. Of special note was the opportunity to meet with CAPT Frank Michael, USN Ret, MOAA National and NWFMOA Member). It was great to see Frank. He proudly registered for the Convention as a member of NWFMOA!

At the **President's Reception**, NWFMOA was honored with multiple awards...I had Fred accept two Col Marvin J. Harris Communication Awards for the Chapter. We received a 4-Star Award for our website and a 5-Star Award for our newsletter, *The Defender*. We also had three members of the Chapter (Fred Westfall, George Colton, and Dan Brown) recognized and awarded FCoC Leadership Awards. A great night for NWFMOA!

Talk about hitting a homerun...the MOAA Foundation awarded 46 grants this year to 42 Chapters nationwide...28% of all the grants went to a FL Chapter. NWFMOA was 1 of 4 nationwide to receive 2 grants and 1 of 2 in FCoC to receive 2 grants!! We received \$4,300 in total grant money (a

\$300 increase over last year)! Great job Dave Parisot!!

Day 2 was chalked full of meetings and opportunities to engage with MOAA National and other Florida Chapters. Some important take aways:

Surviving Spouses need to check to make sure their tax withholding has not been reduced or eliminated. Numerous cases of such action were reported after the death of the MOAA member.

Pat Green (Surviving Spouse Chair) has created a trifold for Surviving Spouses. It is presently at MOAA National for review/publication. Once completed and available, we will request copies for our Surviving Spouses. SBP Open Season ends Dec 31. (This is key info for our members who have remarried).

You can pre-register for burial in a Veteran Cemetery. Surviving Spouses comprise 25% of MOAA's Members

Letter of Excellence...Nationally, 107 LOE submissions were submitted. This year MOAA National will implement a 3-Star rating. (NWFMOA submitted its LOE in March...we look forward to seeing how we scored).

Legislative Update...Discussed importance of sending letters and cards to our elected officials on topics which protect our earned benefits.

FCOC Board Meeting with MOAA CEO (Gen Kelly)...Special meeting for FCoC Board and AVPs. I was asked to attend to represent NWF area. Gen Kelly reminded us that MOAA is bipartisan, not apolitical. We must work with both parties to be effective in protecting the earned benefits of those who have served. It is important for our elected officials to keep their word regarding earned benefits, otherwise the current generation of those who served will not promote serving to the next generation.

Day 3 was meetings focused on 2024. Starting in 2024, Chapters will be rewarded for scoring well on their self-assessment. Those in Green will be awarded \$100. A Chapter deemed most improved will be awarded \$250. We are presently Green. Congratulations...Let's keep leading the charge.

In closing, the FCoC Chaplain briefed us on FireWatch...a Veteran Suicide Prevention effort. A flyer describing the effort and the need for Veteran Volunteers is available on page 12 of this publication.

Convention Ended. We cleared the hotel and began the 5+ hour drive home.

NWFMOA Facebook is alive and thriving. Please check it out and join our group. Big kudos to Jim Shoff for getting this up and running.

FPL presented the NWFMOA Scholarship Fund with a check for \$3,600. Dave Parisot and I received the check from Bernard Johnson, FPL, at the Fort Walton Beach Chamber of Commerce First Friday Breakfast in front of all assembled Chamber Members. Of special note, Bernard will be our guest speaker at our monthly luncheon on July 6th. Please plan to join us.

Ted Corcoran, President/CEO Fort Walton Beach Chamber of Commerce, hosted a meeting between NWFMOA and Operation Holiday Cheer. At the meeting both entities discussed the purpose of their community outreach program. The Chamber expressed interested in helping us both reach our targeted recipients.

In closing, it was another great month for NWFMOA. Thank you to all for your commitment to **Never Stop Serving**.

I flew Presidents H.W. Bush and Clinton.

-I finally retired in 1996 and then flew the Boeing 747, 757, 767 and was a simulator instructor for United Parcel Service (UPS) from 1996 to 2015.

-In 2019 we purchased our home in Niceville and moved there permanently in 2021.

-I'm married to Jane and all our children live in the Washington D.C. area.



Member Spotlight

Al Stearns, Lt Col, USAF (Retired)

My military story from 1969 until 1996 and beyond. I was attending the Univ of NH in May of 1969. Received a job offer in the mail from Uncle Sam. Took the physical and retreated to the local AF recruiter. Was accepted for OTS and follow on for UPT. Commissioned on Jan 23, 1970, and went to Vance AFB. Unfortunately, I washed out and became a Munitions Maintenance Officer. First base was Tyndall. Life was good, but in April 1972 it got better. I met my future wife in the O Club, 2Lt Carol Stearns. I soon left for Thailand. I became the Base Explosives Safety Officer at the largest weapons storage area in the AF. It was here that my baptism by fire happened. I was a 1 Lt and my boss went home for Christmas and left me in charge of base safety. Linebacker 2 started, and very soon I had planes crashing both on and off base. The good news was I survived. The better news was my 2Lt fiancé arrived on Jan 9th 1973 in



Bangkok and we hustled to the Embassy and were married by the ambassador.

She returned to the "world" and I joined her at the end of my one-year tour. We headed Cannon to AFB. This has to be the worst CONUS base. Ι begged AFMPC every Fri to get us to heck out of there. In the meantime, we were expecting our first

child. Out of the blue, I got posted to RAF Bentwaters (with a 2 week show time). Carol resigned, we sold a new house, sold 2 cars, found a home for our dog, and we made the trip. I was suddenly the top secret nuke officer and we loved our 3 years. Carol never knew what my real job was.

In 1978 it was back to Hurlburt Fld. We came with our 2 sons (both born at RAF Lakenheath). Promotion to Maj was looking dicey, so I resigned. Carol had reentered the AF Reserve at Eglin as the AF Reserve recruiter. The night I resigned she swore me into the AF Res in our living room.

Promo to Major soon followed and 7 years later Lt Col. She followed suit and we both retired in July 1996 as Lt Cols. Our last assignment was as Air Liaison Officers at the USAFA.

As a civilian I held several jobs. I was a Financial Advisor for a military Insurance and Investment co for 4 years. Then we purchased an interior decorating business that we retained for the next 35 years. I purchased a travel agency and then worked for many years at the FWB Chamber of Commerce. Finally I joined the funeral business where I have been the chaplain ever since.

My most significant accomplishment was serving until retirement. But in reality, the best achievement was marrying my best friend which has taken us to 50 years of happiness.

My favorite base was RAF Bentwaters and the job was very important and rewarding in the NATO Cold War. My military life needs to be paired with that of my wife. We learned that we had to be ready for whatever curve balls they sent our way, i.e., leaving a base in 2 weeks for an overseas assignment. Also in 1991, Carol was recalled to active duty for Desert Storm. I became a dependent for the first time.

As a result of our jobs, we both ended up being disabled vets, but we are enjoying life. We love to travel, we have 5 grandchildren, and we stay very busy with our hobbies. I sing barbershop and Carol is a professional quilter. Along the way I found time to be the last President of TROA here. MOAA took over after my year. I have been fortunate to have been the leader/Pres of many local non-profits and am now a docent at the USAF Armament Museum.

I am an advocate for young men and women to enter the military and to learn how to become an adult with vast opportunities to lead. I would advise young military folks to do the very best they can, listen to their senior NCO's, always tell the truth, even when painful, and strive to be the best they can be. Be prepared for the unexpected, roll with the punches, and keep faith in yourself, and your country. Some things in life are difficult to accept, some things fall into your lap. Take each event and turn it into an opportunity to excel.

CALL to ACTION 23-03 Tricare for Life Fees and Cost Sharing

Fellow NWFMOA Chapter Members,

If you haven't read Dave Parisot's Legislative Liaison feature in the April *Defender*, I strongly encourage you to do so. In the article you will learn the Congressional Budget Office (CBO) has made two recommendations regarding our Tricare for Life (TFL) benefit. Both recommendations (if enacted) would cost us significant more money in fees and deductibles to use our earned benefit if Congress doesn't act to stop it.

CBO Recommendation #1 (Fees)...We would be required to pay an enrollment fee of \$575 (individual) or \$1,150 (family) for TFL coverage.

CBO Recommendation #2 (Cost-Sharing)...We would be required to pay a deductible of \$850. After the deductible (\$850) is met, TFL would pay only 50% of the next \$7,650 in Medicare expenses.

If you agree this is wrong (as I do) and want to join MOAA's efforts to have these recommendations thwarted, I respectfully request you send the Act Now! message that MOAA has drafted regarding this topic to Representative Gaetz, Senator Scott and Senator Rubio. You can access the Act Now! message to our elected leaders by going to our website (<u>nwfmoa.org</u>) and clicking on the take action button on the bottom of our page. Feel free to make changes to the proposed wording of the message. I also recommend in addition to your name at the bottom of the Act Now! message you add NWFMOA Member. We want our elected representatives to know we are advocates for our members and the military / Veteran community we serve,

CALL to ACTION 23-02 H.R.1413, The Expanding America's National Cemetery Act

Fellow NWFMOA Chapter Members,

MOAA National is advocating for authorizing the transformation of a VA-run national cemetery into the next location that affords military honors as Arlington National Cemetery reaches capacity. This is a long-term solution and needs our support. Florida has the second largest number of military retirees -210,073. We need to advise Congressman Gaetz to protect the benefit of in-ground burial with full military honors for all who plan for internment or inurnment at a DoD managed National Cemetery.

I respectfully request you go to the MOAA website's Advocacy page and send the Act Now! message that MOAA has drafted regarding this topic to Representative Gaetz. If you want, you can change the proposed wording to your liking. I also recommend in addition to your name at the bottom of the Act Now! message you add NWFMOA Member. We want our elected representatives to know when NWFMOA comes up on the net regarding an issue important to our members and the military / Veteran community we serve. Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure. We are met on a great battlefield of that war. We have come to dedicate a



portion of that field, as a final resting place for those who here gave their lives that that nation might live. It is altogether fitting and proper that we should do this.

But, in a larger sense, we cannot dedicate -- we cannot consecrate -- we cannot hallow -- this ground. The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract. The world will little note, nor long remember what we say here, but it can never forget what they did here. It is for us the living, rather, to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us -- that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion -- that we here highly resolve that these dead shall not have died in vain -- that this nation, under God, shall have a new birth of freedom -- and that government of the people, by the people, for the people, shall not perish from the earth."

Let us not just remember the commitment and sacrifices that have been made to the Constitution of this nation but also the commitment to Almighty God who His sovereign grace gives us strength to keep such a document alive as a witness to the freedom we choose to possess.

NWFMOA Receives MOAA Foundation Grants for 6th Consecutive Year; NWFMOA Members participate in FWB Memorial Day Service; Chapter Member Paul Singleton 'King for a Day' for FWB Chamber

On May 12th we were notified by the **MOAA Foundation that we received two Community Outreach Grants this year**, our sixth consecutive year our Chapter has received grants. The <u>first grant of \$1,500</u> is for a continuation of one of our Community Outreach projects from the most previous three years, i.e., to purchase commissary gift cards for young enlisted families (E-4 and below) at our local bases. The <u>second grant, for \$2,800</u>, is to participate in the 2023 Veterans Stand Down this fall by purchasing cold weather clothing and toiletry items for needy Veterans in our area.

This will be our fourth consecutive year of purchasing Commissary gift cards in \$25 denominations to distribute to local junior enlisted families. We plan to again partner with the First Sergeants Associations at Eglin, Hurlburt, and the 7th Special Forces Group(A) and the Hurlburt Military Family Assistance Center to get the gift cards to those in greatest need. In our Community Outreach projects for 2020, 2021, and 2022, we distributed a total of 610 gift cards to young enlisted families at a combined value of \$15,250. Of this total, the MOAA Foundation provided \$11,325 and \$3,925 was from local donations (primarily by NWFMOA Chapter members). With the high rate of inflation over the past year, particularly for food items, the needs and benefits of this outreach program is in greater need.

We need your help with donations for this year's commissary gift card program. Earlier this year we had set a goal to raise at least \$6,000 to purchase 240 gift cards. This year's MOAA Foundation grant of \$1,500 for this project is much lower than anticipated, but, that just means we have to raise more funds from local donations. If each of our Chapter members would donate funds to purchase 1 or 2 gift cards (\$25 - \$50), that would put us 'over the top' (you may donate a higher amount if you desire). Donations may be made at any of our upcoming monthly member luncheons or by mailing a check <u>payable to NWFMOA</u> to P.O. Box 1213, Shalimar, FL 32579. Please enter something on the <u>Memo</u> on the check such as "Family gift cards" or "Commissary gift cards" to designate it for this purpose. In this day and age, it is a shame that we still have junior enlisted families that are receiving supplemental food assistance (formerly known as 'food stamps').

With our second grant of \$2,800 from the MOAA Foundation, we will purchase warm weather clothing and toiletry items for the annual Veterans Stand Down, and distribute the items at the event. As the time for that gets nearer this fall, we will be asking for a few volunteers to help to bag the items beforehand, and to help distribute the items to the Veterans at the event. The event date and location is still being worked out.

We had a good turnout of NWFMOA members at this year's **Memorial Day remembrance** service at the Beal Cemetery in Fort Walton Beach. I noted at least 18 Chapter members in attendance.

The morning started early at 7:00AM in the morning when 35 JROTC cadets from Fort Walton Beach High School approached the gravesites of 1,800 military Veterans, hand saluted (3 seconds up, 3 seconds down), and placed a United States flag at their headstones. By 9:00AM, over 1,800 graves had been decorated. Per JROTC instructor Mark Batcho, Col., USAF, Ret., this is one of their annual events with the most cadets participating. The JROTC also provided the color Guard for the service to present the Colors. (see photos below).
