Where Were You On Nov 21, 1970?

I was in high school so I was rather oblivious to the drama that was playing out half a world away. The date marks the execution of Operation IVORY COAST or Operation KINGPIN, depending on who you ask, which had as one objective the release of American POWs in North Vietnam prisons. The fact that the camp was vacant is the point which is the center of most stories.

You'll hear differently. But it was far more than a rescue attempt and we're fortunate to have a member of our chapter, Lt Gen LeRoy Manor, Jr.,

who actually planned the entire operation. The photo you see is that of (a much younger) Gen Manor giving an outbrief of the mission to President Nixon. He has an excellent descriptive slide presentation to augment his remarks.

It'd be pure hubris for me to summarize Gen Manor's presentation, so I won't. I will say that hearing his remarks will be a very unique opportunity that very few have ever heard—much less from the person who planned it. Searching for

this subject on the internet will reveal a wide range of opinions and much less fact. Wikipedia officially terms the mission as a failure. Without stealing Gen Manor's thunder, I'll just say that he has a different perspective.

Gen Manor has given this presentation many times in the past and especially at military schools. It normally takes

about two hours. He and I talked at some length about how much to abbreviate and finally agreed that two monthly meetings presentations is the minimum amount of time



necessary to do justice to the subject. Anything less would be a cursory summary of events with no time for insight into planning and strategy. So... ..I expect our meeting for June and July will run a little longer than normal so plan on that in advance. Those who still work and are limited to a fixed period for lunch may well have to leave early and we understand. We just didn't want to condense the description of the operation to a point that it becomes meaningless.

Col Phil was 51-years-old and in the prime of his work and family life. He was TDY to oversee repair of hi-tech equipment. He flew 3000 miles and worked 12 to 14 hours a day till he completed the mission.

One evening he went to dinner with his two partners and then to the fitness center to play basketball. They had a good workout, letting go of a week of job stress. When they all went to take a shower Phil suddenly collapsed to the floor. One friend tried to give him CPR, while the other called 911.

The paramedics were unable to revive him. They transported him to the hospital, but further efforts were futile. I was part of the casualty notification team back in the states to inform his wife and three children that the father husband they kissed good-bye 5 days ago had a massive heart attack.

I called his two friends who were still in shock and disbelief. "We were shooting hoops, cutting up and having a good time; I still feel it's all surreal." The other was very angry: "How could this happen to my good friend so dedicated to his family, church and country?"

It is easy to believe we are all in the best of shape and need little preparation before embarking on each new day. Medical science can observe your physical health to a limited degree, counselors your mental well being yet many ignore the critical dimensions of spiritual and emotional health. I like millions believe there is more to life than what we see with our physical eyes—now and after we die. So ask many— "Are you involved in a

The Army's Birthday: 14 June 1775

When the American Revolution broke out, the rebellious colonies did not possess an army in the modern sense. Rather, the revolutionaries fielded an amateur force of colonial troops, cobbled together from various New England militia companies. They had no unified chain of command, and although Artemas Ward of Massachusetts exercised authority by informal agreement, officers from other colonies were not obligated to obey his orders. The American volunteers were led, equipped, armed, paid for, and supported by the colonies from which they were raised.



In the spring of 1775, this "army" was about to confront British troops near Boston, Massachusetts. The revolutionaries had to re-organize their forces quickly if they were to stand a chance against Britain's seasoned professionals. Recognizing the need to enlist the support of all of the American seaboard colonies, the Massachusetts Provincial Congress appealed to the Second Continental Congress in Philadelphia to assume authority for the New England army. Reportedly, at John Adams' request, Congress voted to "adopt" the Boston troops on June 14, although there is no written record of this decision. Also on this day, Congress resolved to form a committee "to bring in a draft of rules and regulations for the government of the Army," and

voted \$2,000,000 to support the forces around Boston, and those at New York City. Moreover, Congress authorized the formation of ten companies of expert riflemen from Pennsylvania, Maryland, and Virginia, which were directed to march to Boston to support the New England militia.

George Washington received his appointment as commander-in-chief of the Continental Army the next day, and formally took command at Boston on July 3, 1775.

Gen William L. Kirk, USAF (Ret)

Gen. William Kirk, one of the USAF leaders credited as a "father" of the Aggressors and the Red Flag exercise, commander of US Air Forces Europe, a two-time MiG killer, and a noted expert in electronic warfare, died April 26 in the local area. He was not a chapter member.

What does Memorial Day mean to you? For many, it's the unofficial beginning of summer; a day for family gatherings, baseball games, and barbecues. But for others — especially those who have served in the military and their families — it's a time to pause and remember why we celebrate this very special day.

Across the nation, MOAA members will support efforts marking this day of remembrance by laying wreaths, giving speeches, playing taps, marching in parades, participating in flag ceremonies, and conducting memorial services to pay tribute to our nation's men and women who fell in the line of duty. But I, like many, don't need Memorial Day to serve as a reminder of the price we pay when we put our young people in harm's way. My son, James Casey Joyce, a U.S. Army Ranger, died Oct. 3, 1993, in Mogadishu, Somalia, in the worst firefight since Vietnam. That day, 18 young men lost their lives; six were from Casey's unit, the 3rd Battalion, 75th Ranger Regiment, from Fort Benning, Ga. Casey was 24 and my youngest. For me, Memorial Day is my opportunity to remind everyone in every way I can — speaking at events, writing about my son, giving interviews, and working on the Field of Flags in Granbury, Texas — about the five Rangers (Jim Cavaco, Richard Kowalewski, Dominique Pilla, Lorenzo Ruiz, and Jamie Smith) who died in combat along with Casey, and all those who have died in the conflicts in Iraq and Afghanistan (6,828 at last count).

All across the U.S. on Memorial Day, our grateful nation comes together to honor these men and women. More than 1 million have fallen in combat during the 241-year history of our nation. We should all pause to remember them and honor their selfless sacrifice.

In Granbury, we remember and honor our military through A Field of Flags. On Highway 377, 1,000 flags will be waving in the breeze, each representing an individual, unit, or branch of service. This Memorial Day, spend some special time with your loved ones, but take time to reflect on our freedoms that our husbands, wives, sons, and daughters have died to protect.

Bowlegs Torchlight Parade which we've been part of for the past several years. As of this writing, Dave Parisot is still looking for people to act as safety walkers for our "float." I'm been part of that in the past and it's very reassuring to see the public's response to our entry.

All of this positive recognition of veterans is certainly deserved and appreciated but also is in stark contrast to the "welcome home" that Vietnams vets got in the 60s and 70s. While I was too young to be one of them, I did have a glimpse into how horribly they were treated and heard from others firsthand that their service was certainly not appreciated.

In light of that, the presentation for June will bring back many of those memories. Gen Manor's comments will show what positive actions were taken, albeit by the military itself, to bolster pride in wearing the uniform. I also can't avoid parallels to the Doolittle Raid. Both raids didn't accomplish any military gains in the traditional sense but certainly bolstered public opinion and were rallying cries to those still in harm's way.

So there's still time to be part of the many military-related celebrations this month. Try and be part of at least one! And Gen Manor's presentations will be a rare insight into an important event during the Vietnam War, so if you miss it you can't say you weren't notified.

Follow-Up on Proposed Florida Sales Tax Holiday for Veterans

In the March Defender I wrote about three bills that had been filed in the Florida House and Senate to provide a "**sales tax holiday**" for Veterans. The bills proposed varying numbers of days and types of purchases that would have been exempt from sales taxes. This year's State legislative session ended on May 8th with none of these bills for veterans being adopted; they 'fizzled on the vine'. There were two sales tax exemption bills adopted for hurricane preparedness purchases (3 days) and for 'back-to-school' purchases (3 days). Check local media for implementation dates.

Eyes are now focused on the Florida Governor's office in regard to the **2017 state budget** which was finally passed by the Legislature on May 8th. Will Governor Scott veto the entire budget, thereby forcing a special session of the Legislature? Will the Governor use his 'line item veto powers' to cut spending in the budget, and, if so, to what level? Again, stay tuned to local news reports. Florida is one of 46 states with the line item veto. The six states without it are Rhode Island, Nevada, Indiana, North Carolina, New Hampshire, and Vermont.

As to **medical marijuana**, the Florida House and Senate could not reach agreement on rules to implement last year's Amendment 2 passage. Thus, these regulations will now defer to State health agencies through their lengthy 'rule-making process' with multiple postings and public meetings to reach agreement. One issue here is that "rules" do not carry the weight of statutes implemented by the Legislature and Governor. The Legislature could, however, call a special session to address this issue.
