Mother Father Pastor Sister Chaplain Beggar Soldier

Welcome to November, home to the Feast of Saint Martin of Tours. Veteran's Day (a band formerly known as Armistice Day) is celebrated on his feast day, November 11. Those of us who feel compelled by the mystery of the all things saintly may find it beyond coincidence that the Armistice was signed on Saint Martin's day given his personal military history. I love Martin of Tours because his narrative partly responsible for my vocational identity and the place other chaplains and I have in your lives. If you enjoy what you read here today, give St. Martin the credit. If not, of course, blame me.

Martin was born to a pagan military family 1700 years ago (fourth century) in what are now Italy and France. At 15 he followed his father's path and joined the Army. He had a big heart and took care of sick, poor and hungry people. Legend has it that he was so humble he refused to let his servant wait on him. He had heard of Christianity and believed he had already integrated Christian practices into his life, so he decided to study so he could be baptized.

Martin was baptized a Christian at 18, became a monk and eventually bishop of Tours. There are various stories of how long he remained a soldier and how he came to leave the army, but all involve his refusal to take up arms and fight. It seems he became convinced that peace and nonviolence were the proper ways to live as a Christian.

While still a student and soldier, Martin encountered a poor man begging near the gates of Amiens in the north of France. It was winter and snow was falling. The beggar was shivering in the cold asking passersby for help, yet people walked by as if the man didn't exist. Martin had nothing with him save weapons, so he took off his warm soldier's cloak, cut it in two, and gave half to his poor neighbor. The following night Christ appeared to him in a dream clothed in a piece of that cloak and said, "Martin, the catechumen [student preparing for baptism], has clothed Me with this mantle! Truly I tell you, whatever

you did for one of the least of these my brothers you did for me."

The French word for "cloak" is *capella*. After Martin became famous and beloved, priests going into battle with armies carried *capellas* with them to remember and honor Martin's sacrifice. Hence the priests themselves became known as *cappellanus*. The title "Chaplain" is derived from *cappellanus*.

People call me "Chaplain Shirley" or "Chaplain Sarah" or just plain "Chaplain," with an occasional "Chaps" and "Chappy" thrown in. I'm old enough to remember when my own church (Episcopal) refused to ordain women. I found it personally very hurtful and wish I'd had the maturity to handle that hurt more constructively than I did for many years. But that's another story altogether. The point is that when we did finally ordain women there was huge discussion about what "lady priests" should be called. The conversation on that has continued and I am often asked some version of this question, "If I call a man priest 'Father' what do I call you?" Since my path took me into institutional, community and military ministry, I have an easy out: "Call me Chaplain."

St. Martin of Tours provided my answer almost two thousand years ago by an act of kindness, charity and sacrifice. How many answers might we discover and problems might we solve if we follow Martin's lead and care for others, especially sick, poor and hungry children, women and men? This Veteran's Day honor St. Martin by doing acts of service and charity to Veterans suffering from poverty, illness and hunger.

Scholarship Fund Needs Your Help!

The Northwest Florida Military Officers Association, Inc. is required to perform community service as a part of its commitment to being a tax exempt veteran's organization. The principle community service the Association has chosen is supporting the high school JROTC programs in Okaloosa County. The Association incorporated NWFMOA Scholarship Fund, Inc. as a 501(c)3 organization making donations tax deductible to the extent allowed by law.

Our Fund has been operating since approximately 1981. Jack Sirney was president of the NWFROC (our former mnemonic) during the Fund's inception. Clif Jordan was one of the early presidents and served for about 20 years. Bill Cullen, Frank Glunn and others were on the board when the Fund incorporated in 1997. In 2002 Frank Glunn became president and served until his recent demise. Bill Van Hoesen is the current president, Tammy Karamarinov is secretary-treasurer, and Bob Padden, Norm Blakley and Bob Allen serve as directors.

Okaloosa County JROTC students are beneficiaries of the Fund's awards. Each year one junior and one senior from each high school JROTC corps receives an award, plus one senior from all county high schools going on to college and continuing in the ROTC program is awarded

a scholarship. This past year the Fund provided five \$250 awards, five \$500 awards and one \$3000 scholarship award. All of these winners, and selectees from DeFuniak Springs H.S., also receive a MOAA certificate and medal. The cost of last year's awards and administration exceeded \$7,000. How do we afford that?

In 1997 an effort was begun to raise \$100,000 through member donations and community support. The plan was for the Fund to be eventually self-sustaining, after all, with 5.5% interest and awards totaling about \$2,000, it was doable even with inflation. Currently though, interest is 0.8%, and that only brings in \$900 for our fund total of \$114,000. For many years the Association has donated money, amounting to around \$1,000, raised by sponsoring the annual military ball. Also, the Fund used the opportunity to solicit area merchants and obtain goods and services to auction at the Ball, thus another \$1,000 was raised. Direct contributions, memorials, the monthly 50-50 raffle and the 500 Club make up the difference. Volunteers assist the Fund each year during the holiday season fund raising period; volunteers do not have to be Association members although most are. Volunteer workers are most active in October and November. The Fund has an established list of merchant donors and we solicit new donors, but we need help in face-to-face contact. If you can spare some time in advance of the holiday season and directly assist the youth of our county, contact Bill Van Hoesen (bvanhoesen@cox.net or 225-2957.

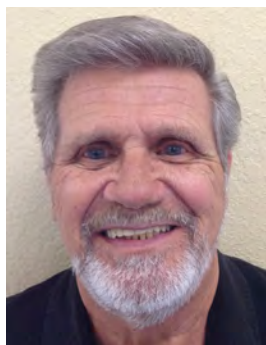

Legislative Musings...

As you probably know, the Pentagon will be faced with another installment of \$52 billion in cuts for FY 2014 if Congress does not take action soon. In his September column of "The Bottom Line," MOAA's

Director of Government Relations, Col. Mike Hayden, USAF (Ret), explains that without a sequestration fix, DOD's budgets options go from bad to worse next year and beyond.

The Budget Control Act of 2011 chained a ticking time bomb to America's national defense capabilities and the devastating cuts from sequestration began on March 1 - resulting in furloughs, force cuts and reduced training hours. Unless Congress acts to repeal sequestration and replace it with an alternative debt reduction deal, another even more devastating round of defense cuts will be required.

While debt reduction is a national priority, such a disproportional share of this burden should not be imposed on military families who already have sacrificed more for their country than any other sector of Americans. It is time for Congress to put partisan politics aside and develop an alternative debt-reduction package that more fairly balances required sacrifices and avoids disproportional penalties for servicemembers and retirees and their families.

Ask Congress to stop sequestration now! Ask your elected officials to set aside partisan politics and repeal sequestration now. Below is a MOAA recommended letter for your use. [Extracted from MOAA Legislative Update, 20 Sep 2013]

"The Budget Control Act of 2011 chained a ticking time bomb to America's national defense capabilities, and the devastating cuts from sequestration began on March 1 - resulting in furloughs, force cuts, and reduced training hours. Unless Congress acts to repeal sequestration and replace it with an alternative debt reduction deal, another even more devastating round of defense cuts will be required.

DOD will likely resort to drastic cuts to cope with sequestration if it isn't repealed, including:

- Acceleration of force drawdowns
- Further reductions in flying hours and training drills and a 10% reduction in operations/maintenance accounts
- 15-20% cuts in modernization accounts

- Involuntary reductions-in-force to reduce civilian personnel costs and hiring freezes
- Halting all accessions, promotions, permanent change of station moves & discretionary bonuses.

Cutting an additional \$52 billion from the defense budget for the next fiscal year would be a disaster as we continue to send our service men and women into harm's way in Afghanistan and face potential threats from elsewhere. While debt reduction is a national priority, such a disproportional share of this burden must not be foisted on the backs of military families who already have sacrificed more for their country than any other segment of Americans.

Please put partisan politics aside and develop an alternative debt reduction package that fairly balances required sacrifices and avoids disproportional penalties for servicemembers, retirees, and their families."
