He leased 137 acres to the City of Valparaiso on which an airport was established in 1933. In 1934. Plew offered to donate 1,460

contiguous acres for a bombing and gunnery range to the U.S. government. This became the headquarters for the Valparaiso Bombing and Gunnery Base activated on 14 June 1935 under the

command of Captain Arnold H. Rich. The Bombing and Gunnery Base has now become Eglin Air Force Base. With this being the ground work for the history of Eglin AFB, we will have the

> pleasure of having the great grandson of the late James E. Plew, James P. Ruckel Sr., to give us a history lesson on his family's relationship with Eglin in the past, present, and future. Jim, as many of the locals know him by, was born in Valparaiso, FL, and is an official "Boggy Boy". He began work with his father at **Ruckel Properties**

in January 1979, was promoted to Vice President in 2002, and became president of Ruckel Properties in 2005 where he continues today.

AUXILIARY NEWS

August is the perfect time to contact your local congressional representatives because legislators are back in their home states for the annual August recess and anxious to meet with their constituents.

Recently, the House passed its version of the National Defense Authorization Act (NDAA), which included a provision to increase the Special Survivor Indemnity Allowance (SSIA). The SSIA is payable to military survivors whose Survivor Benefit Plan (SBP) annuities are reduced because they also receive Dependency and Indemnity Compensation (DIC) from the VA for their sponsor's service-caused death.

In the House provision, the SSIA payment would increase from \$90 under current law to \$163 by FY 2013, with modest increases to follow in later years. This approved provision also will extend the SSIA program through 2021, which under current law would expire Oct. 1, 2017.

Unfortunately, this provision was not included in the Senate version of the NDAA. That means we need your help to support the House provision when the two chambers hash out their differences in conference committee this fall.

MOAA urges you to take this opportunity to contact your local congressional representative or set up an appointment to visit them and discuss SSIA. You can find contact information for your local representative by calling the Capitol Switchboard at (866) 272-6622 or by using visiting http://capwiz.com/moaa/dbq/officials. While you have their ear, there are two other issues that are of great importance to MOAA and all surviving military spouses.

SBP/DIC offset: MOAA for years has pushed to have the offset between SBP and DIC repealed. Unfortunately, this year there were no bills that included this repeal. Make sure your representatives know the importance of ending this offset.

Medicare/TRICARE payment cuts: Unless Congress acts, the Medicare and TRICARE payments to physicians will be cut 29.4 percent on Jan. 1, 2012. If this cut goes through, it will have a devastating impact on access to health care for TRICARE and Medicare beneficiaries.

Lessons From Afghanistan, Part Two

Last month's column closed with these words: "For today, I'm going to focus on being kind, acting like I'm the person I want to be, and taking time to pay attention to other people. Stay tuned . . . in next month's

column I'll let you know if it was worth it!"

Well, dear readers, every time I managed to be kind (especially when I didn't feel like being kind), it was worth it. However, I didn't always manage. Which brings us to the second point: I need more practice at acting like I'm the person I want to be. That practice should make me into a kinder, gentler soul. And surely a kinder, gentler soul would pay attention to others regardless of distractions. The closer I get to leaving for the States, the harder it is for me to truly pay attention to other people. I am rather focused instead on all the things on my all-important task list as well as those I've forgotten to list!

Conclusion: attempting to live my first three lessons learned, "Being kind is always the better way," "'Act as if' really works if you do it long enough," and "There's never enough time, but there's always time enough," is definitely worth it as long as I don't indulge in guilt-tripping myself when I don't measure up.

As I'm getting closer to redeploying (when you read this I should be on my way to a party at my brother Mike's house!), many people ask me to share the most exciting thing that has happened in my time here. I will now flatter myself by assuming you want to know, too. And then I'll let you know the last, and perhaps most meaningful entry on my list of "Lessons from Afghanistan."

Since arriving last July, I have experienced much excitement, which hopefully I'll get to tell you about sometime. But nothing can beat this:

I conducted a special worship service and invited anyone who wished to come forward to receive a blessing with the Holy Water which I had just consecrated along with some instruction about Christian traditions of making

Holy Water (this was a mixed crowd, Christian, Muslim, and Hindu). Since it was a Christian event, it was perfectly appropriate to do the Holy Water thing. As the men and women came forward, I asked each one his or her name and religion so I could give an appropriate blessing. I expected a couple of Baptists, some Catholics, maybe a Lutheran, lots of "just Christians," etc., and I was not disappointed. I put water on their foreheads and said their names, and, while making a damp sign of the cross, "Remember your baptism, and be thankful."

Then I got what I did not expect: Hindus and Muslims, all men, inviting this lady priest to bless them with water that had been sanctified using a Christian formula. A couple of Hindus, a dozen or more Muslims, welcoming my blessing. For a few moments the universe expanded into something no doubt very close to the society God has in mind for us.

So, Sarah's top four lessons learned from a little more than a year in Afghanistan:

- 1. Being kind is always the better way;
- 2. "Act as if" really works if you do it long enough;
- 3. There's never enough time, but there's always time enough; and
- 4. Continue to believe in, hope for, work toward, dwell in, and (dare I say it) *expect* love and hospitality. Always.

May the God of your understanding bless you and keep you.

Legislative Musings...by Bill Van Hoesen

Let's get the important news out of the way first. Please be advised the Florida state legislature overwhelming passed Senate Bill 228, known as the "Pull Up Your Pants Bill." Now I gotta ask you, with the country and state pretty much in the dumpster, don't you think they have more

important things to do than worry about some kid's buttcrack showing? Besides, when did the clothes kids wear to our local schools become the business of the state? Talk about a Nanny-State.

Now, on to more mundane matters. Up to 28 Jul 2011, 2,676 House and 1,433 Senate bills had been introduced in the 112th Congress. Most will not make it into law, thank the Lord. A good indication on the likelihood of a bill being forwarded to the House or Senate for passage and subsequently being signed into law by the President is the number of co-sponsors who have signed onto and support the bill. An alternate way for it to become law is if it is added as an addendum to another bill such as the annual National Defense Authorization Act (NDAA) and survives the conference committee assigned to iron out the differences between the House and Senate bills. At http://thomas.loc.gov you can review a copy of each bill's text, determine its current status, the committee it has been assigned to, who your representative is and his/her phone number/mailing address/email/website to communicate with a message or letter of your own








Between the fields where the flag is planted, there are 9+ miles of flower fields that go all the way to the ocean. The flowers are grown by seed companies. It's a beautiful place close to Vandenberg AFB, CA. The floral flag is 740 feet long and 390 feet wide and maintains the proper flag dimensions. This flag is 6.65 acres and is planted with five pointed stars comprised of white larkspur. Each star is 24 feet in diameter; each stripe is 30 feet wide. This flag is estimated to contain more than 400,000 larkspur plants with 4-5 flower stems each for a total of more than 2 million flowers.

(Editor's note: This is not a hoax as verified by Snopes.com—search for "floral flag" and get additional information. I've personally seen these flower fields located near my first duty station in the Air Force and where I met my bride-to-be.)
