## **Pew Perspectives**

Beautiful weather complete with cherry blossoms greeted more than 160 members of the MOAA board of directors and staff, council and chapter Presidents from all 50 states, and members of the association's Currently Serving Advisory Council, Currently Serving Spouse Advisory Council, and Auxiliary Member Advisory Committee as they gathered for the 2013 Storming the Hill lobbying event. The teams delivered the message, along with a fact sheet on issues such as sustaining the 1.8-percent military pay raise and barring unfair TRICARE fee hikes.

The proposed 1-percent pay cap fails to keep military pay comparable to the civilian workforce as indicated by the Bureau of Labor Statistics' Employment Cost Index. Previous pay caps affected the retention and readiness of our all-volunteer force. The past three military pay raises averaged less than 1.6 percent (the lowest in 50 years). It would be grossly inappropriate to cap pay increases for service members while we are still at war.

Once again, disproportionate TRICARE fee hikes affecting military retirees are proposed in the FY 2014 budget. These hikes, which would increase annual fees, impose meanstesting and increase pharmacy co-payments. The 2012 and 2013 National Defense Authorization Act increased fees, including pharmacy co-payments, and required future increases be tied to the military COLA. DoD documents support the fact that military personnel and their health care costs are not the problem. In fact, the problem lies in the inefficiency and mismanagement within DoD. Any changes to TRICARE fee law would represent a breach of faith with those who have already paid extraordinary premiums in sacrifice and service through their 20-plus year military careers.

Detailed fact sheets were left with congressional leadership and staff on concurrent receipt for disabled military retirees (S.234 and H.R. 333), the Survivor Benefit Plan/Dependency and Indemnity Compensation offset (S. 734 and H.R. 32), and the Guard/Reserve retirement issue (S. 240 and H. R. 690). While we were encouraged by responses from most legislators, we encourage you to contact your legislators on these issues, too. To call your legislators' offices toll-free,

Its handmaiden is fear, usually fear of what unattractive things we might discover about ourselves if we put down the shields of pride, rightness (as opposed to the idea that we just might be wrong), "nobody will do it as well as I do it" and other bits of psychic armor. Antidotes to pride include worship and praise...when we remember through actions, thoughts and words that there is a power greater than ourselves we increase in humility. Other simple actions are praising others for jobs well done, taking suggestions and advice from colleagues, family and friends, studying things we think we already know well,

The Florida Tax Holidays are August 2-4, 2013. The sales tax exemption applies no matter how many items are sold on one invoice to a customer! The sales tax exemption is for clothing, footwear, and "certain" school supplies, school accessories, computers and "certain" computer accessories. There is a \$75 maximum purchase price on the clothing, shoes and certain accessories; \$15 for school supplies, and \$750 for the computer. So, if you want \$100 popular brand jeans for your children or grandchildren-forget it! If you want your student to be the fastest runner on the track team with \$100 track shoes--forget it! But, if your student will wear the \$50 jeans and the 2nd place \$74.99 running shoes--you are golden! The rules get tricky so before you buy, know how the exemption works. # Welcome! You've Been Scammed!

At last month's meeting, Rick Anderson highlighted recent emails which attempted to get password/account information and threatened to shutdown his Cox account. RULE #1: DON'T RESPOND. The senders are frequently from Cox accounts which have been compromised. Here's the recommendation:

If originator is NOT a Cox account: Forward <u>as an</u> <u>attachment</u> to <u>spamreport@cox.net</u>.

If originator IS a Cox account: Forward <u>as an attachment</u> to <u>phishingreport@cox.net</u>.
